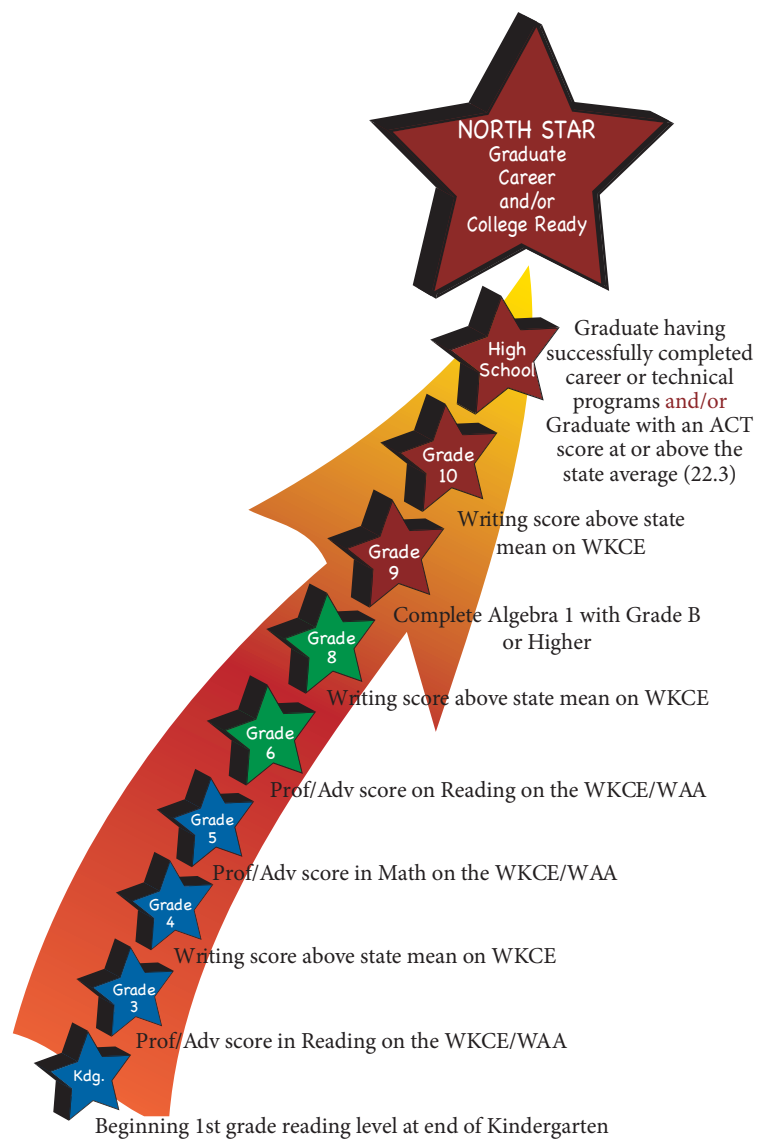

Magnet Schools

Jefferson Lighthouse Elementary combines 60 percent identified intellectually gifted children with 40 percent open enrollment children.

Bull Fine Arts Elementary is designed to develop the understanding, skills and creativity of students in art, music, dance and drama, as well as creative language.

Red Apple Elementary specializes in science and environmental education.

Walden III Middle and High School is focused on students as individuals. The school develops personal relationships with students and families.

Charter School

REAL Middle and High School provides an educational setting that helps students become accountable for their own education and motivates them to become joyful, lifelong learners.

Youth Apprenticeships

Case, Horlick and Park High Schools offer Youth Apprenticeships that allow students to experience career options with classroom and on-site, work-based learning.

Extended-Day Programs

Racine Virtual Learning

RUSD is now offering virtual learning courses for students who have a unique educational need, such as those who aren't able to attend classes on campus. Courses are available in a wide variety of subjects, ranging from math and reading to Chinese and computer programming. A mentor teacher develops relationships with students and ensures their progress during the course. A content teacher delivers the content. Bilingual Education Programs

Dr. Jones, Fratt, Julian Thomas, Mitchell, S.C. Johnson and Wadewitz Elementary Schools offer bilingual programs in which students learn English and Spanish.

Year-Round School

Janes Year-Round Elementary allows students to go to school all year round. The schedule includes three trimesters that consist of 60 days in session and 20 days not in session.

Early Learning Programs

P-COC (Parent-Child Oriented Classroom) offers the unique opportunity for parents to explore and learn with their three-year-old child in the classroom.

4K (4-Year-Old Kindergarten) is a half-day educational program filled with learning and activities for four year olds. There is no cost for 4K for students who live in the District.

Advanced Placement (AP) Courses

Horlick and Park High Schools offer college-level AP courses through which students can potentially earn college credit.

Technology in the Classroom

Technology Refresh

In June 2010, RUSD launched a Technology Refresh program, distributing new Apple MacBook Pro laptop computers to all teachers in the District. All classroom computers were replaced and the number of computers available for student use was increased. In total, the District received 8,000 new computers. The new computers are being leased through Apple and will be replaced every four years. By reprioritizing District dollars, the District was able to complete the Technology Refresh with existing funds.

Schoolnet

RUSD is implementing an instructional management system known as Schoolnet. This system will align our curricula, lesson plans and District resources with the Common Core and Wisconsin state standards and goals. Schoolnet will also allow RUSD teachers and administrators to access, evaluate and transform comprehensive student data into actionable knowledge to effectively improve student instruction. The technology refresh has made it possible for all teachers to access Schoolnet, allowing collaboration to improve student learning and help us achieve the North Star.

Instructional Technology

RUSD is committed to providing students with the technology resources and instruction necessary to thrive in a technology-driven society. RUSD's technology resources for students and staff include:

- ▶ 750 SMART Boards (interactive white boards)
- ▶ 725 Elmo document cameras (3-D, color overhead projectors)
- ▶ 8,500 Apple computers
- ▶ 432 iPod Touches
- ▶ 450 iPads

Gorman Named Apple Distinguished Educator

In the spring of 2010, the technology company Apple named RUSD Technology Coordinator **Sue Gorman** an Apple Distinguished Educator (ADE). Gorman was one of only 76 educators in the country to receive this honor. According to Apple, ADEs are visionary educators and innovative leaders who are doing amazing things with technology in and out of the classroom. Gorman's role in the District is to help educators integrate innovative technology into their classrooms with the goal of raising student achievement.

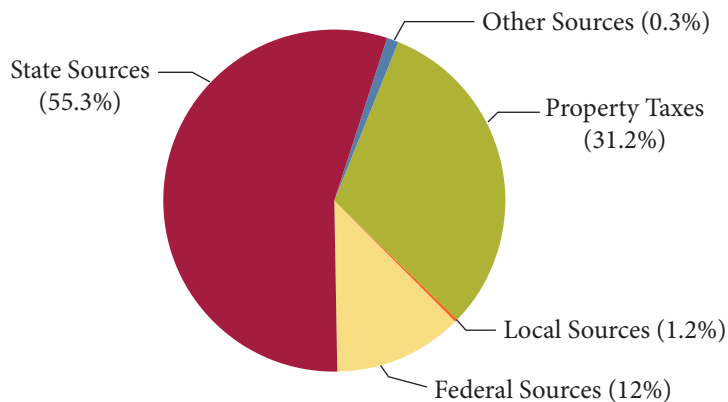

Budget & Finances

How School Finance Works

RUSD receives its funding from the following sources (figures are budgeted for the current school year):

Sources of Revenue



In 1993-1994, the state developed revenue limits to control the amount of revenue school districts can collect through general aid and local property taxes. Traditionally, the limits allowed districts to receive an increase in per student revenue each year. The limits were increased every year since they were put in place, up until the current school year when each district's base revenue was decreased by 5.5 percent, which equates to \$11.5 million for RUSD. The decrease in revenue limits and reduced state aid to RUSD caused overall District spending to be reduced by more than nine percent.

In addition to the limit on revenue, overall state aids were reduced. This means that RUSD will receive approximately \$13.2 million less in 2011-2012 than we did in 2010-2011.

School Vouchers

In July 2011, the Wisconsin legislature passed a state budget provision known as School Choice (or vouchers) that will allow students living in RUSD to attend participating private schools with taxpayer money that comes in part from taking funding from Racine Unified's general fund. If all 250 available vouchers are used for the 2011-2012 school year, RUSD will experience an additional \$618,400 cut in general aid. In 2012-2013, the limit is 500 vouchers. If all vouchers are used, RUSD's general aid would be reduced \$1,236,900. And in 2013-2014, when the cap on the number of vouchers that can be used is eliminated, it is estimated that the District could lose as much as \$5 million based on a 20 percent participation rate.

Budget Process

Each year, the legislature, governor and federal government decide how much funding will be given to education. This year, RUSD faced a \$25 million deficit and funding reductions of over \$18 million, including:

Reduction in spending per student and state aid cut	-\$11.5 million
Reduction in state high-poverty aid	-\$0.92 million
Reduction in state aid to fund private school vouchers	-\$0.56 million
Reduced or discontinued state categorical aid	-\$3.00 million
Reduced or discontinued federal aid	-\$1.64 million
Other reduced or eliminated funds	-\$0.81 million

Total reduction to 2011-2012 budget: \$18.43 million

While revenue at the state and federal level were reduced, the amount of revenue the District can collect from local taxpayers was also reduced. This budget cycle, the revenue reduction from the state was greater than the amount of spending the District was required to cut, thus the District was allowed to make up the difference through local property taxes. This year, the District saw a \$0.53 increase per \$1,000 of home value, increasing the mill rate from \$8.41 for the 2010-2011 school year to \$8.94 for 2011-2012.

Cost-Saving Measures

Over the last several years, RUSD has made many cuts throughout the District in order to create efficiencies and reduce spending, while still maintaining a focus on learning and student achievement. The District has attempted to keep cuts as far away from the classroom as possible. Cuts that were made for the 2011-2012 school year to meet the \$25 million deficit include:

- Employee benefits were reduced:
 - Employees now pay 5.8 percent of their salary for the Wisconsin Retirement System (WRS) contribution.
 - Health insurance changed to a high deductible plan: \$2,000 per year for single and \$4,000 for family.
 - Salary schedules were frozen.
- 119 positions were eliminated:
 - 2 teachers
 - 83 educational assistants
 - 14 secretaries/clerks
 - 8 administrators
 - 12 buildings and grounds employees
- Over-time hours were reduced.
- Energy savings were implemented through closing swimming pools for part of the year, reducing electronics such as printers and implementing energy-efficient lighting projects.

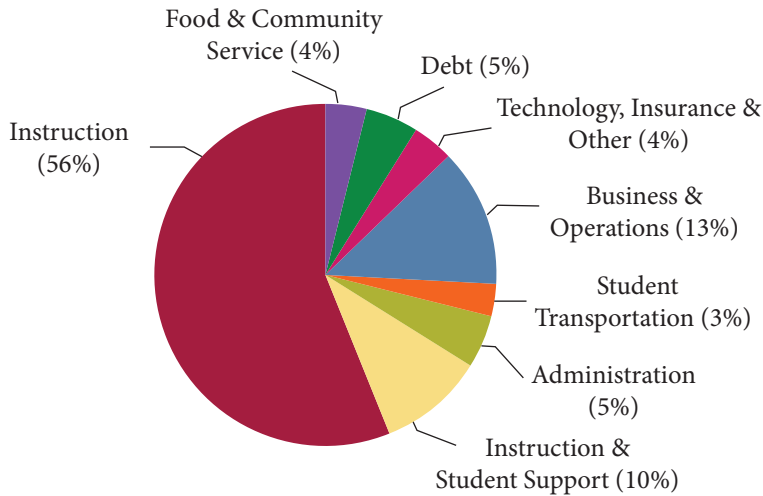

RUSD carefully targets its dollars to have the greatest impact on the classroom and student learning. The following is how we spend our resources (figures are budgeted for the current school year):

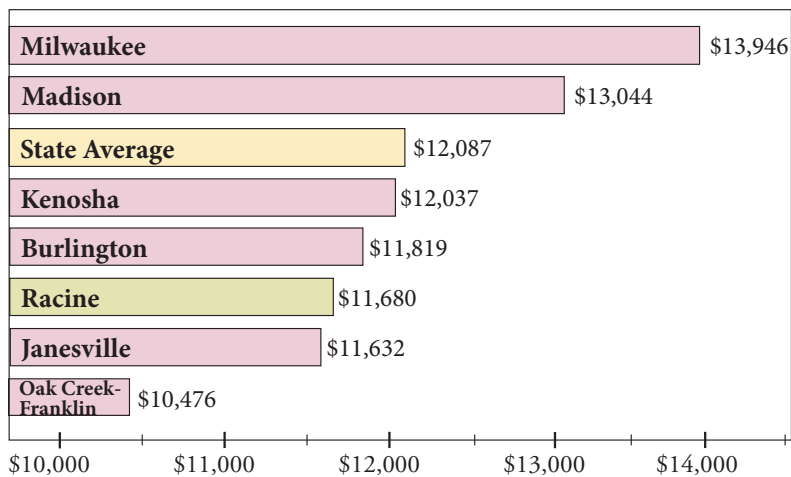
Use of Funds by Function

Raising Achievement for all Students

Student Achievement & Accountability

Over the last several years, RUSD has worked hard to create ways to measure and track progress, collect and analyze data and develop plans to increase student achievement.

Testing

WKCE Standardized Test

RUSD administers the Wisconsin Knowledge and Concepts Exam (WKCE) in the fall of each school year. WKCE is required as the state's measure for the federal No Child Left Behind (NCLB) Act. District scores determine whether schools are making Adequate Yearly Progress per NCLB. Students in grades three, five, six and seven take tests in reading and math. Students in grades four, eight and 10 take tests in reading, math, science, language arts, writing and social studies. The WKCE serves as an important measure of student achievement, and the success benchmarks on the North Star trajectory are tied to students' results on the WKCE.

MAP Testing

Measures of Academic Progress (MAP) assessments are administered to students in various grades three times per year. MAP tests serve as the District's benchmark assessment and measure academic progress in math and reading.

Data

Over the past year, RUSD has worked to implement Schoolnet, an instructional management system. Schoolnet will allow RUSD teachers and administrators to access, evaluate and transform student data into actionable knowledge tailored to improve instruction.

Measures of Achievement & Accountability

District Scorecard

The District Scorecard is aligned to the North Star Vision and represents reasonable and achievable targets for performance related to North Star achievement, staff capacity, managing and aligning resources and student and community engagement.

The scorecard was first developed in 2008 and measured data from the 2008-2009 school year. With the completion of the 2010-2011 District Scorecard, RUSD had three years of data to analyze and determine areas of strength and growth as well as areas for improvement.

School Improvement Plans

Every school in Racine Unified has a School Improvement Plan (SIP), which is the map used to chart its way to achieving the North Star. Clearly-defined goals based on the North Star are included with each plan. All RUSD SIPs were developed by school teams comprised of multiple stakeholders and are currently being implemented in the schools.



McKinley Middle School students **Savannah Bowen** and **Jared Simonsen** received Maestro Awards at a national music competition in Anaheim, Calif.

Fifty-one out of 52 students who participated in the Youth Apprenticeship school-to-work initiative successfully completed the program.

Rachel Margis was voted All Racine County Girls Swimming and Diving Athlete of the Year.

Areas of Achievement

In 2010-2011, the District saw areas of great improvement, including:

- ▶ **3.8 percentage point increase** in the number of 2011 graduates taking the ACT exam
- ▶ **7.1 percentage point increase** in the number of 10th grade students meeting or exceeding the District's writing proficiency standards
- ▶ **9.3 percentage point increase** in the number of ninth-grade students successfully completing Algebra I with a grade B or higher
- ▶ **29.5 percentage point increase** in the number of eighth-grade students meeting or exceeding the District's writing proficiency standards
- ▶ **3.8 percentage point increase** in the number of fourth-grade students meeting or exceeding the District's writing proficiency standards
- ▶ **3.7 percentage point increase** in the number of kindergarten students reading at the first-grade level
- ▶ **98 percent** of Youth Apprenticeship students successfully completed the program
- ▶ **44 AP Scholars**, an increase of more than 37 percent over the previous school year
- ▶ **3 National Merit Finalists** received scholarship awards
- ▶ **\$3.5 million in scholarships** were awarded to a total of 298 high school students to pursue higher education
- ▶ **3 high schools** achieved composite ACT test scores above the national average
- ▶ **2 high schools** achieved composite ACT test scores above the state average
- ▶ **4 students** received full IB diplomas

Focus for 2011-2012

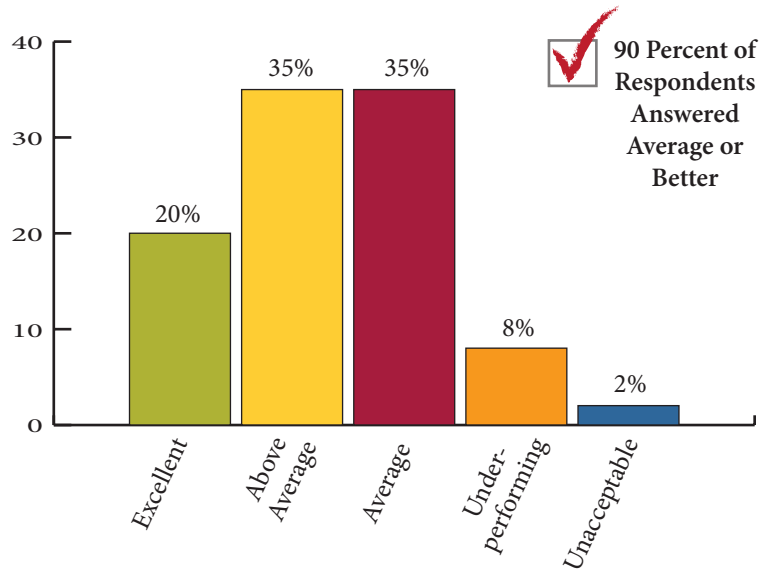
In reviewing test scores and data from the 2010-2011 school year, RUSD recognizes the need for an increased focus on improving achievement in math. Some of the initiatives that have been or are being implemented for the 2011-2012 school year related to math include:

- ▶ The District implemented a new research-based math program for grades K-5. The new materials feature both increased use of hands-on activities as well as technology-based learning.
- ▶ The District will provide double-block algebra classes for ninth-graders who need additional math support.
- ▶ Schools and teachers will start implementing the Common Core State Standards in math, with an emphasis on classroom best practices.
- ▶ The District will use the Schoolnet data system to help teachers plan lessons based on standards and District curriculum and to access exams and test scores.

RUSD Survey

In spring 2011, RUSD conducted an online survey of parents and community members. The survey focused on general satisfaction and communication. Results indicate an overall positive impression of District schools:

How do you rate the overall quality of education services provided by the school your oldest child attends?



Additional Survey Highlights

- ▶ 77 percent of respondents rated the overall quality of education services provided by RUSD as average, above average or excellent.
- ▶ 42 percent of respondents felt very or pretty well informed about issues impacting education and their local district and 43 percent feel somewhat informed.
- ▶ Respondents most wanted to receive communication about:
 1. Reasons for decisions made by the District
 2. How well the District is performing compared to others
 3. Curriculum/educational program options
 4. Budget, tax, finance, election and funding updates
 5. Safety-related incidents and precautions
- ▶ 66 percent of RUSD parents who responded agreed or strongly agreed that there are opportunities to express their concerns and opinions regarding issues at their child's school. Fifty-one percent agreed or strongly agreed that their concerns and opinions are seriously considered by school administration.
- ▶ 81 percent of respondents agreed or strongly agreed that they receive good customer service when visiting their child's school.
- ▶ Respondents prefer to receive information via e-mail, parent portals, newsletters and the District website. They least prefer to receive communication via social media and District TV.
