DESCRIPTION: Removal of existing roof systems and replacement with new roofing

system. Work includes removal and replacement of the roof system and a section of metal exterior siding associated with the roof at Case

HS.

Bids were received and opened on March 24, 2015. Four (4) total bids were received with a Base Bid range of \$1,109,350 to \$1,299,500. Alternate Bid Number 1 for the removal and replacement of Roof Area 3 ranged from \$96,550 to \$127,000. Alternate Bid Number 2 for the removal and replacement of roof area 4 ranged from \$96,181 to \$130,000. Alternate Bid Number 3 for the removal and replacement of

roof area #5 ranged from \$186,112 to 280,000.

The bid recommended for acceptance is that submitted by FJA Christiansen Roofing Company, Inc. for the base bid and Alternate Numbers 1, 2 and 3 in the total amount of \$1,488,193 and is

appropriate based on the requested services.

FISCAL NOTE: The base bid for the project is \$1,109,350. Alternate #1 is \$96,550.

Alternate #2 is \$96,181. Alternate #3 is \$186,112. The total of the

project would be \$1,488,193.

RECOMMENDATION: Acceptance of the responsive bidder, FJA Christiansen Roofing

Company, Inc.. for the roof replacement at Case HS as set forth in the bidding documents and bid response for the base bid and Alternate Bids

#1, #2 and #3 for a total of \$1,488,193.
