Dear Parents and Guardians,

We have had a wonderful fall at the Academies of Racine at Case High School! We are excited about expanding our opportunities to learn and experience career-related education, starting our International Baccalaureate Middle Years Program with our 9th graders, and starting it next year with our 10th graders. As a learning community, we are continually looking to improve our scholastic and academy experiences at The Academies of Racine at Case High School. The school report card is one resource we use to reflect on our strengths and areas for improvement.

The Department of Public Instruction (DPI) is required by state statute (<u>Wis. Stat. 115.385</u>) to generate a school report card and district report card for every publicly funded school and district in the state. The report cards are intended to help schools and districts use performance data to celebrate successes and improve their efforts to prepare students for their futures. The current school report card is primarily based on last year's performance during the 2021-22 school year. Due to the COVID-19 pandemic, DPI encourages caution when interpreting scores and ratings on the 2021-22 report cards.

At the foundation of the report cards are four priority areas. Schools and districts receive a score for each priority area:

- Achievement proficiency in English language arts (ELA) and mathematics on the annual state assessments
- **Growth** year-to-year progress in ELA and math achievement
- Target Group Outcomes outcomes for students with the lowest test scores: the Target Group.
- On-Track to Graduation reliable predictors of how successfully students are progressing toward completing their K-12 education.

The priority area scores are aggregated into an overall accountability score, from 0 to 100. This score is displayed on the front page of the school or district report cards. It is important to note that the 0 to 100 accountability score is not a "percent correct" measurement. Based on its score, a school or district receives one of five rating categories, from *Fails to Meet Expectations* to *Significantly Exceeds Expectations*, as well as corresponding one to five stars.

I want to share these results with you because they help illuminate some of our successes and help pinpoint areas of focus in our school. But as DPI stresses, these report cards are just one source of information about our school. Here are some additional results that show we are moving in the right direction.

- 860 of our 2020-2021 students successfully completed at least one Dual Enrollment course. This represents 50.6% of our students which is 32% higher than the state statistics.
- 128 of our 2020-2021 students earned at least one industry-recognized credential.
- The number of English Learners in Basic grew in both Mathematics and English Language Arts.
